Before racing I will affect adequate and suitable insurance with third party liability. I will also ensure my crew is made aware of the undertaking in this declaration, the importance of effecting appropriate personal insurance and their responsibility in rules observance, in particular RRS 1.2 (wearing personal buoyancy adequate for the conditions).
